As the Senior Vendor Managed Inventory (VMI) Manager, this position is responsible for the implementation, operations and management of programs and facilities supporting our US and international customers. This includes project management, customer relations, employee coaching and development, and operations management. This positon currently includes supervisory management and leadership of approximately 25 employees at multiple locations in North America and globally. We are looking for an individual with a background in program management, with knowledge of aerospace, distribution, customer service, and process improvement. This positon requires a self-starter with the ability to multi-task in a fast-paced environment within the aerospace industry. The position will include implementing VMI programs with key customers including Forward Stocking Locations (FSL) in some cases throughout the states and internationally. In addition, the individual may be working with our leadership team to help create standard work processes for our wide variety of customer support activities. This position will be based out of our headquarters located in Chatsworth, California and reports directly to the Vice President, Operations and Quality.

Key Responsibilities:

- Maintain the VMI programs and assists with different projects within Forward Stocking Locations (FSLs) to provide new and innovative support to our customers.
- Perform product Bin Mapping on customer production floor and set-up bin systems to provide service to VMI customers.
- Flexible schedule to travel domestically and internationally. Travel may exceed 25% at times.
- Supervise employees remotely located at customer facilities in North America and globally.
- Ability to use logic, reasoning, and strong problem-solving skills to deliver great results.
- Must speak, read, and write English fluently, and Spanish, French, or Mandarin speaking is a plus.
- Must have a good driving record and be a US citizen.
- Possess a physical ability to lift up to 50 lbs. occasionally.

- Perform walkthroughs of customer sites to verify bin systems remain in good working condition and make routine updates to ensure continual functionality.
- Provide assistance with projects in the Chatsworth facility, report problems, make suggestions for improvement, and provide status updates to the VP, Operations & Quality.
- Monitor space layout to ensure efficient space utilization for the VMI programs as well as FSL set-ups.
